BANK RESTRUCTURING

Some of our recent bank restructuring work highlights include:

- Advising a lender in relation to the proposed restructuring of the target (in receivership). The scope of work included advising the client on the power of the receiver under the proposed restructuring, alternative restructuring options and undertaking a limited vendor due diligence in respect of the target.
- Advised on the restructuring of Delphis Bank Limited.
- Acting as part of the legal team which attempted to revive Daima Bank Limited.

CAPITAL RESTRUCTURING

Our recent corporate restructuring work highlight includes:

- Advised the Government of Kenya (**GoK**) (through the office of the Attorney General) on the proposed capital restructuring of Kenya Airways Plc in which the GoK is a significant shareholder, including the legal implications of relinquishing its security. The matter value is USD 2.3 billion. This is was the largest and most complex restructuring which aimed at repositioning the national carrier for long-term growth and business sustainability.

CORPORATE RESTRUCTURING

Our recent corporate restructuring work highlight includes:

- Advising in the corporate restructuring of Chase Bank (in receivership). Our role included advising on the powers of Kenya Deposit Insurance Company, the statutory receiver, under the Kenya Deposit Insurance Act, 2012, to undertake the proposed restructuring, including, the powers to require the shareholders in the company to sell their shares and the company to issue additional shares to third party investors. We also provided advise on the legal aspects of the proposed restructuring, the alternative restructuring options, including involving the sale or other disposal by the company of all or part of its assets or the assumption by another person of all or part of its liabilities. The matter value is undisclosed.

DEBT RESTRUCTURING

Some of our recent debt restructuring work highlights include:

- Advising one of Kenya's largest publicly listed companies in the restructuring of its debt, owing from local and international lenders. Our role involves reviewing the contractual documentation, restructuring facilities documents and other security agreements and providing a legal opinion on the debt restructuring.
- Advising the GoK on the legal implications of a proposed restructuring and reviewing restructuring documents, including advice on the applicable law relating to granting of guarantees by the GoK.

ENERGY

Our recent energy work highlight includes:

- Assisting an American firm to review and recommend an appropriate legal and institutional framework in the energy sector and thereafter overseeing the legal aspects of the restructuring of Kenya Power Company and Kenya Power and Lighting Company, in particular assets and liabilities transfer in respect of the power generation and transmission/distribution.

INSOLVENCY

Some of our recent insolvency work highlights include:

- Acting in a contentious case concerning insolvency of a manufacturer of edible salts (directors/shareholders) versus a Kenyan commercial bank in liquidation and receivership as well as providing advice on non-contentious aspects of Insolvency including Employment Law. The case also involves a challenge to the receivership and recovery of monies valued at USD 3.5 million. The non-contentious aspects involved advising the "receiver/administrative receiver" with regards to the discharge of his/their duties under the law, drafting agreements for them to bring about relief for the creditors and the company receivership.
- Representing a Holding company and a leading Kenyan based commercial bank in insolvency proceedings in the matter of Nakumatt Holdings Limited (under administration) where it seeks to exercise its right of forfeiture, repossession and peaceable re-entry of its premises. The matter value is USD 38, 000.

- Advising a leading Kenyan based commercial bank on its rights as a lender against a leading supermarket currently in insolvency; and in particular on the right of a lender to enforce third party securities under the Insolvency Act, 2015. The matter value is USD 7 million.
- Advising and drafting agreements for a consortium of banks involved in a non-contentious insolvency matter with a value of USD 64.5 million. Our role includes advising the consortia on their legal options under contract including drafting agreements.
- Representing a commercial bank in Kenya (in liquidation) in respect of insolvency proceedings touching on two claims. The matter is currently pending before the Court and touching on the inter-play between Kenya's old Companies Act and the new Companies Act, 2015 and Insolvency Act, 2015 as well as the Kenya Deposit Insurance Act, 2012. The matter value is USD 2.7 million and USD 7.4 million respectively.
- Representing a leading manufacturer of Fast-Moving Consumer Goods in East Africa in an insolvency petition for the liquidation of a Kenyan supermarket chain and where the manufacturer claims USD 670,381 for supplied goods.

PENSION FUND DEEDS

Our recent pension fund deed work highlight includes:

- Advising and representing lenders and secured creditors in the administrative proceedings of ARM Cement.
- Advised Standard Chartered Bank Kenya Limited on the amendment of their pension fund deed and rules in light of their staff restructuring programme.
