PUBLIC NOTICE

WAIVER OF INTERESTS AND PENALTIES ON LAND RATES

The Nairobi City County Government (NCCG), Nairobi Metropolitan Services (NMS) and the Kenya Revenue Authority (KRA) hereby give notice to all land rates payers that H.E. the Deputy Governor and the Ag. Governor, NCCG in collaboration with the Director General, NMS has approved 100% waiver on outstanding penalties and interest for those who will pay for all outstanding principal arrears between 1st October to 31st October 2021, both days inclusive.

To take advantage of the waiver, billing and payment for the amount due will be undertaken through the Nairobi Revenue System (NRS). To access the waiver, ratepayers are required to create an NRS account by the following steps:

- 1. Go to https://nairobiservices.go.ke or download Nairobi e-Services App from Google Play Store.
- 2. Click on "Create Account" and select Individual tab (for individuals or Sole Proprietorships) or Non-Individual tab (for other organisations and business types).
- 3. Provide your ID Serial Number, your KRA PIN number, and your Phone Number as prompted.
- 4. Enter the One Time Password (OTP) sent to the phone number provided above for Individual accounts and the Passcode sent to the official organisation's email address for non-individual accounts.
- 5. Create your account Password to complete the creation of your account.

Once the account has been created, ratepayers should send their LR Number, or a copy of their latest land rates payment receipt and National ID/ KRA PIN copy to landrateswaiver@kra.go.ke or call 0709014747 to provide the same details to get an NRS waiver bill.

Alternatively ratepayers can visit the following areas with the above documents to be assisted in both account creation and billing for the waiver:

- . Waiver Customer Care desk at the Sunken Parking, Agha Khan Walk
- NMS Customer Care Desk at Green Park Bus Terminus (former Railways Club)

All payments shall be made through the following channels quoting the NRS Bill Number as your **Payment Reference Number:**

Kindly note that after paying using the above procedure, your land rates account is automatically updated in NRS and you can obtain your receipt by loging into your NRS Account. There shall therefore be no requirement to go to City Hall or Sub-County Offices for receipting.

NOTE: At the end of the Waiver Period, enforcement measures shall be initiated against defaulters for recovery of the principal, interest and penalties of accrued land rates.
